RELATIONSHIP BETWEEN THE PARTIES



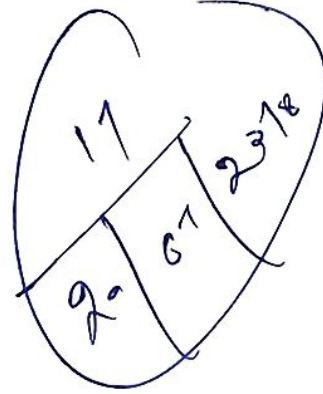
